



## Classroom Teacher with Curriculum Responsibility Job Description

Title and Grade of Post: Class Teacher plus TLR2 (Curriculum Leadership – English)

Responsible to: Headteacher, Deputy Headteacher, Key Stage Leaders

### Job Purpose and main expectations of the role:

In addition to providing a model of excellence when discharging the duties and responsibilities of a classroom teacher, the main responsibility of this post will be to take overall leadership for further developing English across the school. This will involve liaising and providing support for teachers, subject leaders, reporting to SLT and Governors on developments and evaluating impact on pupil progress and attainment.

The scope of the role includes:

- Being an inspirational role model for curriculum leadership, promoting curriculum areas throughout the school and securing commitment for us to provide the very best opportunities and experiences for our children;
- Providing all children with an exciting and engaging learning experience which captures their imagination, makes them happy and motivates them in school;
- Working with SLT to secure high quality leadership, development and management of teaching, learning and the curriculum for all pupils;
- Further developing, monitoring and reviewing a progressive, skills based, creative curriculum;
- Taking a lead role in the professional development of staff on aspects of teaching, learning and the curriculum;
- Being a leading professional, actively and positively promoting effective teaching and learning practices across the school;
- Working with SLT in the development and review of all policies, systems and procedures relating to the quality of teaching, learning and the curriculum;
- Inspiring subject leaders to commit to further refining an innovative curriculum which is relevant for our social context and challenges aspirations;
- Making a significant contribution to raising standards across the school through quality of teaching and learning in the classroom and beyond;
- Supporting less experienced members of staff and being a mentor and coach in improving quality of teaching;
- Working in partnership with the Headteacher, governors and staff to ensure the continuous improvement of the school.

This job description is not an exhaustive list of duties and may be amended at any time, according to the changing priorities of the school as identified within the school's strategic improvement plan and in consultation with the post holder.

All members of the teaching staff are required to carry out the duties of a teacher as set out in the current 'School Teachers Pay and Conditions 2017' document. See appendix A extract.

**POST THRESHOLD TEACHERS** are required to be highly competent in all elements of the Teachers' Standards. Their achievement and contribution to the school should be substantial and sustained. They should act as role models for teaching and learning, make a distinctive contribution to raising standards across the school, continue to develop their expertise post threshold and provide regular coaching and mentoring to less experienced teachers.

**What does distinctive contribution mean at Bowhill?**

By considering the progression from the core standards through to the post threshold standards we can identify some key aspects, which mainly fall into three categories. UPS1 teachers will be demonstrating they implement these consistently in their teams, UPS2 teachers will be able to demonstrate they implement these consistently across the school and UPS3 teachers will demonstrate they implement these consistently across the school, day in, day out.

## PREAMBLE

Teachers make the education of their pupils their first concern, and are accountable for achieving the highest possible standards in work and conduct. Teachers act with honesty and integrity; have strong subject knowledge, keep their knowledge and skills as teachers up-to-date and are self-critical; forge positive professional relationships; and work with parents in the best interests of their pupils.

## PART ONE: TEACHING

A teacher must:

### 1 Set high expectations which inspire, motivate and challenge pupils

- establish a safe and stimulating environment for pupils, rooted in mutual respect
- set goals that stretch and challenge pupils of all backgrounds, abilities and dispositions
- demonstrate consistently the positive attitudes, values and behaviour which are expected of pupils.

### 2 Promote good progress and outcomes by pupils

- be accountable for pupils' attainment, progress and outcomes
- be aware of pupils' capabilities and their prior knowledge, and plan teaching to build on these
- guide pupils to reflect on the progress they have made and their emerging needs
- demonstrate knowledge and understanding of how pupils learn and how this impacts on teaching
- encourage pupils to take a responsible and conscientious attitude to their own work and study.

### 3 Demonstrate good subject and curriculum knowledge

- have a secure knowledge of the relevant subject(s) and curriculum areas, foster and maintain pupils' interest in the subject, and address misunderstandings
- demonstrate a critical understanding of developments in the subject and curriculum areas, and promote the value of scholarship
- demonstrate an understanding of and take responsibility for promoting high standards of literacy, articulacy and the correct use of standard English, whatever the teacher's specialist subject
- if teaching early reading, demonstrate a clear understanding of systematic synthetic phonics
- if teaching early mathematics, demonstrate a clear understanding of appropriate teaching strategies.

### 4 Plan and teach well structured lessons

- impart knowledge and develop understanding through effective use of lesson time
- promote a love of learning and children's intellectual curiosity
- set homework and plan other out-of-class activities to consolidate and extend the knowledge and understanding pupils have acquired
- reflect systematically on the effectiveness of lessons and approaches to teaching
- contribute to the design and provision of an engaging curriculum within the relevant subject area(s).

### 5 Adapt teaching to respond to the strengths and needs of all pupils

- know when and how to differentiate appropriately, using approaches which enable pupils to be taught effectively
- have a secure understanding of how a range of factors can inhibit pupils' ability to learn, and how best to overcome these
- demonstrate an awareness of the physical, social and intellectual development of children, and know how to adapt teaching to support pupils' education at different stages of development
- have a clear understanding of the needs of all pupils, including those with special educational needs; those of high ability; those with English as an additional language; those with disabilities; and be able to use and evaluate distinctive teaching approaches to engage and support them.

### 6 Make accurate and productive use of assessment

- know and understand how to assess the relevant subject and curriculum areas, including statutory assessment requirements
- make use of formative and summative assessment to secure pupils' progress
- use relevant data to monitor progress, set targets, and plan subsequent lessons
- give pupils regular feedback, both orally and through accurate marking, and encourage pupils to respond to the feedback.

### 7 Manage behaviour effectively to ensure a good and safe learning environment

- have clear rules and routines for behaviour in classrooms, and take responsibility for promoting good and courteous behaviour both in classrooms and around the school, in accordance with the school's behaviour policy
- have high expectations of behaviour, and establish a framework for discipline with a range of strategies, using praise, sanctions and rewards consistently and fairly
- manage classes effectively, using approaches which are appropriate to pupils' needs in order to involve and motivate them
- maintain good relationships with pupils, exercise appropriate authority, and act decisively when necessary.

### 8 Fulfil wider professional responsibilities

- make a positive contribution to the wider life and ethos of the school
- develop effective professional relationships with colleagues, knowing how and when to draw on advice and specialist support
- deploy support staff effectively
- take responsibility for improving teaching through appropriate professional development, responding to advice and feedback from colleagues
- communicate effectively with parents with regard to pupils' achievements and well-being.

## PART TWO: PERSONAL AND PROFESSIONAL CONDUCT

A teacher is expected to demonstrate consistently high standards of personal and professional conduct. The following statements define the behaviour and attitudes which set the required standard for conduct throughout a teacher's career.

- Teachers uphold public trust in the profession and maintain high standards of ethics and behaviour, within and outside school, by:
  - treating pupils with dignity, building relationships rooted in mutual respect, and at all times observing proper boundaries appropriate to a teacher's professional position
  - having regard for the need to safeguard pupils' well-being, in accordance with statutory provisions
  - showing tolerance of and respect for the rights of others
  - not undermining fundamental British values, including democracy, the rule of law, individual liberty and mutual respect, and tolerance of those with different faiths and beliefs
  - ensuring that personal beliefs are not expressed in ways which exploit pupils' vulnerability or might lead them to break the law.
- Teachers must have proper and professional regard for the ethos, policies and practices of the school in which they teach, and maintain high standards in their own attendance and punctuality.
- Teachers must have an understanding of, and always act within, the statutory frameworks which set out their professional duties and responsibilities.
